All,

I appeal to you all as fellow local brethren.

The "blatancy" of my mental condition, to use Mark Bailey's description, is not as evident to the 3 top psychiatric experts as it is to all of you.

They are apologising for the long and irritating manner of the further tests that I will have to go through in view of the opinions of those around me.

So I just wondered whether you may all have the grace to review your stand.

On the other hand, I'm sure they'll find something wrong with me so feel free to reconfirm your stand!

They are concerned at the pressure that I've been under over the past 18 months during which you all have seen deterioration in me.

The fact is that the most pressure has come from you 4 brothers but I realise that none of you see it that way.

More seriously, you believe that you are carrying out BDH's orders.

I wonder whether you should stop and see whether you should be taking responsibility for each of your own actions, as before the Lord.

It's difficult for me to raise this question because Deb and Jed clearly have faith in you 4 brothers that sadly is not shared in the same way by me.

Consequently, there has been a strain on the father/son and husband/wife relationship.

I accept fully that if I had been more submissive to you 4 brothers and given in more readily on the business, family and assembly fronts, then I'd be better regarded by the brethren.

But, to be very honest, I've felt very vulnerable since handing myself over into the hands of my local brethren on 17<sup>th</sup> October 2014.

I have often confessed my poor character to you all and accept fully the appeal from you all to go over the list of horrible things in Mark 7 in order to find the evil in my own heart.

However, I'm appealing to you all on the basis of Matt. 7 v 3 to 5 and Luke 6 v 41 & 42.

I recount 2 of many matters to illustrate my concerns that you could have contributed to the pressure that I was under.

At 11.00pm on Friday 31<sup>st</sup> October, after my 6<sup>th</sup> visit from my 3 priests earlier, I received a phone call from roger to say that my matters were coming before assembly at the CM in the morning

I felt under extreme pressure by this so asked whether it was a 1 Corinthians 5 matter.

Roger would not give me a definitive answer about this so I asked whether it was a matter of evil.

. was left for me to work that out with the Lord.

I offered to stay in for the CM but Chris Stutterheim said that I could come out and that my matters would not be coming up.

I think the worst visit followed on the Monday but at least Garth got the credit for bearing the news that it was not a 1 Corinthians 5 matter. A massive relief for me.

Roger justified his reaction to my question 3 days earlier by saying that he didn't want to start an argument by telling me that it wasn't a 1 Cor. 5 matter.

The other pressure worth a mention was after I wrote my letter to BDH via Garth, putting myself in his hands and those of my local brethren and opening myself up for assembly judgment.

I was desperate to get some acknowledgement either from you 3 priests or from BDH, even if it was just that it was regarded as genuine.

But there was nothing. Garth actually passed judgement on the letter as being "cursory".

I know that there are other cases of concern in the city at the moment eg Phil Bo. and Faye.

Please, please don't put them under anything like the pressure that I've been subjected to, otherwise they might crack under it.

They have my heart felt sympathies.

Sorry to write like this but I do feel quite well in myself despite the grave concerns you all have as to my moral and mental well being.

I don't think that I've ever done any of you a mean trick so I'm restful before the Lord that everything will become clear in the long run.

Despite my aforementioned failings, I can assure you that I have no secret agenda and nothing other in mind than the best for all my local brethren.

But I do remain puzzled about so much and would welcome a "round the table" local review of what's been going on during the time that you have seen me deteriorate.

I think some fresh faces would help!!

Perhaps you'd allow me to have a say in who could help??!
