Dear Father (I have no other!)

Thank you very much for looking after Jed and his family so well and facilitating Deb and Kiri's visit to help them.

They deserve the break (from me!).

I'm undertaking a course of MRI and EEG scans and psychometric tests and will report to you once they are finalised.

I've asked Deb to hand you the enclosed reports.

I enclose the report on the much appreciated interview with you in London and subsequent activities.

Of particular importance to us is whether we proceed with buying the Bramhope Park Hall site outright for £1.16 million.

Phil Beaumont's statement in the assembly last Lordsday prompted me to update Jed's accident report.

Would you be prepared to edit or vet it and decide whether it is suitable to be shared?

Sorry it's so detailed but I've largely kept this to myself since I sent you my first report on the accident in 1998.

I'm concerned that we've maybe missed the bearing of Jed's accident despite your father saying at the time, 'Maybe it's for the whole of Leeds.'

I also enclose my accurate review of the Leeds aspect of the school matter starting 1993/1994. It's interesting to see how Ross Anderson's initiative in setting up a school was, in effect, blocked in the 'nicest' way possible of course.

I just wanted to put on record that I don't believe that you had a true report about my activities in Sheffield and Nottingham, much as I accept that I have a lot to learn.

If you're interested in getting the true picture, you'd get it from Jim Hutchinson, Ray Storry or myself.

Neither did any of us receive any advocacy from our own places. Not that we're complaining!

To be very honest, I'm concerned about my brother Garth's attitude. Although he has since apologised, in December 2013 he gave the attached character reference to Jed and Casey in order to help them understand my character traits.

This has had a negative effect on their attitude toward me, especially at work. (Casey mentioned the psychopath section as being particularly applicable to me!)

However, the business is coming along nicely now and I look forward to UBT visiting tomorrow.

Also, the day after our meeting in London with you, Garth contacted Onemedifund and cancelled my attendance at venues around the country, quoting that you had said last October that I was not to move around??

You should also know that my brother Ralph (age 52) is in gaol again for defrauding people under a 'Ponzi' scheme. He caused untold grief and suffering, by collaborating with criminals and he's also succeeded in discrediting his younger brother Cedric who had to take early retirement from his position as Head of the West Yorkshire Police Fraud Investigation Squad.

Mr Hales, I want to be a son to you. You're a father to me.

I accept the humiliation of all I've been through as from the Lord Himself and am not desiring to rake up history for history's sake, but more for your understanding and scrutiny.

I want to put things behind me and go forward positively in a way that's pleasing to the Lord and yourself.

I am at your disposal.
