Dear Bruce,

Further to my letter to you attached dated 18th April 2024, further exposures as to the NSW 1989 Stewards' Foundation of Christian Brethren Act courtesy of my visit to the NSW Parliament reveal that you must have arranged to take my business over by using my wife when you insisted on taking her away from me and being with you in Sydney in July 2015, see [London Interview](#). During that same year when you took Jed out from under my control for installing a new leg and grooming him according to the Act, you also had my other two sons Josh and Stefan over, got them preaching in front of thousands of brethren and then arranged to meet them at your house after your son-in-law Lester Martin took the reading in Sydney. You then instructed them to resist my protests about the scrappiness and illegality of the partnership and shareholder agreements that I'd been coerced into signing.

Furthermore, you deliberately withdrew from me so that I was no longer a beneficiary of the trusts but that's always been hidden from the courts, courtesy of the NSW 1989 Stewards' Foundation of Christian Brethren Act. You thought you were so clever getting me by the short and curlies and nullifying my salvation all at the same time and persuading your 55,000 congregation that I wasn't worth saving. By simultaneously putting me out of your religious fellowship and the trusts that you control, you confirmed that you run a ruthless business rather than a mainstream Christian church. Presumably you can yourself, with your totalitarian control as the Man of God, nominate who are the beneficiaries of the trusts at my expense. That seems to be why you tried to get hold of my business and put me out on the streets with virtually nothing.

I'm worried that you can evade capital gains tax, stamp duty and other taxes because the beneficiaries of the properties that you own can be any person at any one time and then another another time dependent on your assessment of them.

Did you have a part, Bruce, in setting up this awful Act along with the help of Fred Nile, Ted Pickering and John Howard? By setting yourself up above the laws of the land you are holding the courts of men in contempt which is not only unscriptural but unrighteous as well. Have you ever read 1 Corinthians 6?

Judge Turnbull in the Sydney courts on 4th June 2024 said regarding Colin Betsha that once you are a member of the brethren, you always are. I agree with him and that's why I have applied for

fellowship with the brethren at Morden, Doncaster. You cannot just strip people of their dignity simply because they disagree with your point of view. Neither the law nor money should have anything to do with religious status but you coincide the laws of the land that you've had a part in creating with a spiritual take on things which is utterly wrong because it contradicts everything that you agreed with the British Charity Commission.

No wonder you wouldn't let my wife and I reconcile. You were rather determined to force the devastation of the Act on me by arguing that there were irreconcilable differences between us. She was clearly helping you, cuckolded by my three sons, ever since I resisted your instruction in November 2015 to move £250,000 to the Bailey family from my business accounts. This was straight after I met you in Boston (see [link](#)).

So I repeat that the same move that took me out of my salvation took me out of your trusts as well, despite the fact that I'd devoted my life to serving your empire – Unifocus, UBT, Onemedifund UK etc.

This is devious stuff and totally against your father's teaching.

I assiduously concocted my own index of your father's teachings and can give you volumes of ministry quotes which contradict what you're doing. Your father would be ashamed of you. You've been controlling the narrative for decades to try and make the brethren believe that your father was a great man, but I don't believe you had any respect for his teachings at all. You're one big con man (Proverbs 6 v 12-15) but you haven't managed to con me.

To summarise, I have been excommunicated and consequently put out of trusts due to you pushing the lie that differences were irreconcilable between my wife, my children and I. You knew full well that I would no longer be a beneficiary of the trusts which now own my company, Weavabel. You bowled me out middle stump on both grounds and that proves that the PBCC religion and the business are combined so that the one Act facilitates doing both things all at once, ie using the religion and the business to devastate lives.

Have I made myself clear?

You need to confess this in assembly and instruct Jed immediately to withdraw his bogus case of contempt of court which is being heard on Monday and Tuesday.

It is totally unfair to arrange the marriage of my eldest son to a Bailey and then pitch him against me in numerous court battles.

Again, your only hope is to repent and just count it as a token of my graciousness that I am writing to you again after having already sent you one final appeal on 18th April 2024.
