**Subject:** **Re: Serious Communication with Garth Christie from his older brother Lance which merits a respectful reply**

Garth

Whatever are you doing?

After encouraging your son Neil to put me in jail for a night in December 2022, you're now overseeing a case where Jed's trying to put me behind bars for 2 years

Does it please you that I've been scratching around to find money to live? I've been living off the beneficence of kind compassionate people.

Father died younger than I am now so you must realise the pressure that you cause. He was heartbroken at being let down by the very brethren he had joined at the age of 16.

Judge Cotter warned me that I couldn't cross question you if you were to lie in court so I decided to change tack and bring in a couple of other witnesses who I can rely on to tell the truth

I've just heard that you, via one of your companies, was paid £2.5 million by Sante Global for the Unispace/Sante PPE contracts

The more I look into your affairs, the more inextricably you are linked with the Hales's

I'm also trying to work out why you sold Gloves4U during the pandemic at a time when the assets reduced by over £6 million

I can see how my own business was being weakened during the time that I was being rebuked in assembly so it's quite clear to me that the PBCC and brethren businesses are inextricably linked

Why didn't you tell me about this when I was in fellowship?

I've worked out that I free heartedly contributed around £1 million to the church when I was inside so why take all that away from me?

I suppose I was warned in that I have it in writing that my subdivisional brethren Ryan Lumb and Bruce Dickson told me in November 2016 that I'd "LOSE EVERYTHING AND WE MEAN EVERYTHING" unless I submitted to your way of thinking

I actually regarded that as a threat, especially as you'd rebuked me three times in full assembly by that stage

It's also incongruous that you spoke about the absolute waste of spending money on legal costs when you spoke in the Select Committee meeting along with Bruce Hazel. You said that the money should be used for charity. On the other hand you said that over a principle you would fight all the way to the highest court, even mentioning going all the way to Strasbourg

In the light of this, Jed and the rest of my family were always very clear when I was inside that you were integral to everything that was happening to me. I realised anyway. Those 27 "priestly" visits were terrible

I'd like to bring you back to the money you've "wasted" in attacking me! I realise that you wanted me to give up and admit that you were right and I was wrong but I felt, on principle, that it was right to defend myself against your attacks

Father and mother both died without being vindicated so I felt that this time I should be given fair hearing so that the truth could be established  
Much better to put things right when people are alive than wait until they're dead

And then your classic comment in Parliament "we welcome scrutiny"  
Surely that means that you should respectfully answer all points that I've raised in my letters to you one by one  
Brothers should be able to have robust exchanges and arrive at agreement

Apparently, if I'm sentenced, I'll be in Armley Jail, just like Ralph was  
What was ironic was that it was the very few days that you bailed him out that your warehouse fire started.  
I've written a little article for my lawyers entitled "Tendency, Coincidence, Dogma and Devastation" so be assured that they are just as adamant that I shouldn't be in jail as you are that I should

I suppose Joseph's brothers wanted him in jail. Now that I understand how the Stewards Act coincides with withdrawal to give Bruce Hales control of the assets of persons no longer in fellowship, I realise that I've been sold for a few pieces of silver just like Joseph was  
Remember, it came back to bite them in the end, even though they pretended to be honest men

Before signing off, I remind you of my lawyers plea to you to pay my invoice for costs which is a very similar figure to the amount you received from the Hales's during the Covid crisis  
You should settle that immediately along with the accrued compound interest.
