Garth,

Further to my recent letters, including the one where I detailed the reasons behind the struggles I've faced, I request, for the sake of Weavabel's future, that you fund Jed, Josh and Stefan so that they can buy Unit 1 Focus Way off me now. This would ensure that the majority of Focus Business Park, which I built with the future of my family in mind, stays within the family. The price you need to pay is £300,000 and I have a client ready to proceed with the purchase if you do not. I need the money to cover legal expenses that have been forced on me by you and the PBCC

Throughout the purchase and construction of Focus Business Park, I worked closely with John and Bruce Hales with the intent of streamlining the management and operational processes. Separating the sales and sales process engineering teams into Unit 1 would save unnecessary distractions. Additionally the extra space was intended to accommodate the government-sponsored business growth plan I had committed to with Beaumonts of Wakefield ([link](#)).

I believe that you have profited significantly, to the tune of £8 million, through PPE contracts during the Covid crisis, making this a simple and reasonable request for you to facilitate. Even if my well-being is not your priority, you now hold responsibility for the care of my family and therefore have a duty towards them.

Further to my previous letter, I suggest that you contact Judge Cotter directly via his secretary, June Morgan, in an effort to stay the proceedings. He is presiding over my sentencing in the Leeds courts on 6th September. June's contact details are:

I am ready to stand before any judicial authority whether on earth or in heaven. Are you ready for the same level of accountability, Garth? It seems that you can't even give me an account of what you've done and are doing

To be clear, the effectiveness of the PBCC's attack on my integrity depended on Jeremy Reed's insistence that I had entered into a penal agreement of my own free will which prevented me speaking derogatorily of Weavabel and my family. That is blatantly untrue. I had to do it because of the threat of having to pay over £300,000 of brethren costs, which I didn't have. (I also intervened to protect my son Jed being grilled publicly.) You already know how much I've spent fighting for my rights and that's why you owe me the amount I've invoiced to you ([link](#)) plus compounding interest.

And anyway, when I established my legal right to take back ownership of the business I created, the brethren threatened to walk out.

That proves that you didn't work towards the best for the business at all.

And now I face a jail sentence for protesting at the way you've treated me.

This will all come out in the end.

It seems to me that Ward Hadaway used the New South Wales Stewards' Foundation of Christian Brethren Act 1989 along with you wanting to send UBT officers in to value the business in order to leave me with nothing.

So, unknown to me, simultaneously with my withdrawal, you tried to strip me of everything.

You'll see ([link](#)) how I protested to the NSW government in June after not receiving any reply from numerous appeals to yourself and Bruce Hales.

You can see ([link](#)) that Lloyd Chirnside's businesses across Australia have now been raided by the ATO.

I understand that the ATO are now investigating the Vision Foundation and may be freezing its funds. Is that the run-on from the endowment trust that Bruce Hales was coercing us to contribute to in Vision17?

Being such a loyal PBCC member at the time, I even asked Keith Birch whether I could contribute the £1.26 million repayment (that I received back without interest from Rolf Smaldon of BET) that I invested in Bramhope Park Hall some 8 years earlier! I didn't hear back from him so rang him back and told him to forget it.

Mark Lyon's death needs a thorough forensic investigation. ([link](#)) I've been back in touch with his widow's solicitors two or three times asking for an update, but they

remain silent.

Who can I enquire of with regard to Roz and the children's well-being?

To help you understand my situation, I include an article I wrote on 22nd March 2021 on how the introduction of the commercial system and later UBT has left the brethren relatively unintelligent ([link](#)).

Also Paul Flynn's article dated November 23, 2012 re the PBCC's charitable status which includes your comment "We do not mind any of the questions. We welcome scrutiny. That is not a problem to us. We have nothing to hide" ([link](#))

It's very serious to tell lies to Parliament.

To offset the way that you and Roger Edwards deceived the Leeds brethren on 19th March 2017 and bound your judgement on all 55,000 brethren worldwide, you should insist that my Accountability letter ([link](#)) dated 24th May 2024 is read out to ALL the brethren universally. That would give them the opportunity to judge righteously.

As you would no doubt know, I have applied to my nearest meeting at Morden, Doncaster for fellowship and have here at Noblethorpe Hall 42 bound printed copies of "serious outstanding issues that need urgent attention by the Doncaster and Chesterfield PBCC administration" ([link](#)) dated June 2021 plus a covering letter ([link](#)), Mike Hughes and Phil Hutchinson's letter dated 22nd October 2014 to the Leeds brethren, Ernie Hughes's financial statement dated 18th May 2021, Conversation with Phil Hutchinson 28th February 1998, False Charges raised by Mike Hughes, letter to Duncan Hulbert dated 10th January 2021, Communication with Doncaster and Chesterfield brethren 13th January 2021, Testimony and Comments of Ex Brethren regarding the PBCC compiled 21st December 2020, letter to all the brethren in Sydney 13th January 2020, letter to me from Doncaster "elders" Mike Hughes, Richard Long, Charles Thomas and John West (all younger than me!) 9th December 2016, letter to Bruce Hales 22nd November 2019, Statement re Jim and Louise Hutchinson, The Brethren's Kangaroo Court, Statement of Witnessed Fact by Jim and Louise Hutchinson, article 'Lance really respects people who can change their minds when presented with information that contradicts their beliefs', Implications of the UK human rights act of 1998, application by Charles Hales for apprehended personal violence order against me, letter from Bruce Hales to ME at Boston 15th October 2014 and the aforementioned reflections on BBC behaviour dated 22nd March 2021 ([link](#)).

Roger Edison and yourself were always extremely influential in Doncaster and Chesterfield so I insist that you arrange for collection of these documents from Noblethorpe Hall and distribution to all householders in both places. That will give opportunity for the brethren in both places to judge righteously and decide whether to accept that I have a right to attend Morden on the basis of Revelation 22 v 14 or whether I fall into the category of verse 15.

I've always spoken the truth and never intentionally caused any harm to anyone so I

need to know that you are at last taking me seriously.
