Subject: Birthday Comments and Questions for GAC

Garth

I feel moved to raise serious questions and comment truthfully on this, your 68th birthday

Having taken a lot of trouble to outline the family situation and the fact that Cedric has been targeted and, to a certain extent, psychologically destroyed by Ralph, it's clear that you've been seeking to do the same to me

You must be able to see that, yet you deceive yourself, suppress your conscience and continue to shun me and keep me away from my own family
Two recent appeals to redeem yourself a little by funding a decent price for the last remaining unit on the industrial estate that I built, so safeguarding the expansion of Weavabel, and the need to purchase a property next door to where I live, have both been bluntly refused

Also the invoice that I raised two years ago for £2 1/2 million plus compound interest still remains outstanding

Why?

I devoted my life to the PBCC despite your control, happily gave over £1 million to the cause, compassionately helped those who asked for my help and yet you've been defaming me and trying to run me out of money and get me into jail time and again

And why did all the Leeds gathering join together in 2022 to try to turn me into a criminal?

Yes, I did so much through my life for the very same brethren who have now turned against me

You're my brother, so, apart from my immediate family, know me better than Bruce Hales or any of the other brethren

Why turn my own wife and children against me and try to get hold of all my money?

And why do you ignore all my emails and letters when I'm only appealing for fairness and justice?

And why write a damning witness statement into the court rather than advocate for me?

I've never hurt any of the brethren but do shine a light into dark places as instructed by the word of God

For 4 weeks now I've turned up at Morthen, Doncaster, the source of false charges that you read out in the Leeds assembly, but the brothers there tell me that they're simply forwarding the evidence of wrong doing to you and the very brethren in Leeds who've excommunicated me! You and they are the very people who've destroyed my family so why can't Morthen sort things out according to the principles of Matthew 18 just like I suggested to you and Bruce Hales in the interview at the Hilton Hotel, London in June 2015?

And why did you, Roger Edwards, Chris Stutterheim, John Rich and Jim Hazel all gang up together to persuade my family and the brethren that I was mental?

My bewilderment was a normal reaction to the way that I was being publicly rebuked and treated so badly by you and the very “priests” who knew me and should’ve been advocating for me

I can state categorically that I never set out to harm anybody, only to make sure the truth was dominant rather than persons

That’s why, at the time of the opening of York school, when Mike Harding and you insisted that I had to be submissive to you on the orders of Ross Hales, I said that I’d only do that if you were exemplifying the truth

The fact is that you deceived, not only the Leeds assembly between 2015 and 2017 but also the British government in your presentation to the PASC committee in 2012

It’s clear to me now that your motivation has been to run me out of money, defame me and get me into jail

For virtually all of your life you haven’t made any attempt to understand me, so the net result is a titanic struggle between us both

And you’ve sneakily gone after your sister-in-law and nephews in order to get me. How pathetic is that?

I have to say that you are hostile to my life, devoid of brotherly love and a proxy or acolyte of Bruce Hales

The way that you’ve enforced the provisions of the NSW Stewards Foundation of Christian Brethren Act is repugnant to the British system of justice

You’ve caused the whole demise of my life in the brethren after persuading me to turn against dad and mum and the rest of the family in 1972 to stay in fellowship with brethren who’ve since rejected me

You’re one very ambitious religious zealot who has become the leader of the PBCC in the UK, causing untold psychological damage

Do you enjoy encouraging four of my family to take me on in the courts?

You protect not only your own dominance but that of the PBCC leader and the shunning and judgement dogma that you use to create victims that you do nothing to help

It’s all so coercive and awful, especially when you consider that you’ve turned against me all the 55,000 brethren who fund you

You look so strong and untouchable with all the security, show and big meeting halls you build but you’re actually weak in the eyes of God

Yes, it’s monstrous what you’re doing and people who don’t know you wonder at the power you’ve got

It’ll all come crashing down

It’s devastating tortious interference by a church in marriages and families where one spouse becomes proxy to that interference

I could go on and on

At least, as knowing the Lord, I do offer you recourse to the door of repentance which is something that you didn’t offer me when you were controlling my life in the brethren

So I suggest that you become a man and start repenting.....

And I would like to see all my grandchildren this weekend. It’s been over eight years since I’ve seen them. I’d also like to see my daughters and sons-in-law. I’ve only seen my three sons in court.

Can’t you start moving over on to a line of understanding how I feel and

showing a little compassion and kindness?

I await a reply just like I have done to every single communication I've made to you
