Request for Financial Support for ‘A man Destroyed by the Doctrine of Separation’ (Judge Cotter, Courts of Justice, 1st November 2024).

Dear Mr. Hales,

Having tried to attend my nearest Lord's Supper at Morthen, Doncaster, for five weeks now, and having written to my brother Garth, [Link](#), many times this year. I have to conclude, indeed, that by virtue of the New South Wales Steward Foundation of Christian Brethren Act 1989, nobody in the PBCC has a voice (Proverbs 31:8) on any significant matters apart from yourself and maybe your sons. This means that all the brethren are in bondage to you so need setting free (Galatians 5:1).

Having been in touch with Leeds brethren at the behest of the Morthen (Doncaster) brethren, I'm advised that, despite you love bombing me via my son, Jed, there is no chance of me persuading Garth to allow me back into fellowship. I'm told that it's a “closed shop” and that, if the brethren enquire about me, there's no willingness at all to look into matters. This ties up with the statement [\(link\)](#) read out to all the Leeds brethren by Roger Edwards in April last year and means that there's nothing left but for me to appeal to you directly, Mr. Hales.

Apart from involving lawyers, you've ignored the 15 letters that I've already sent to you since I was excommunicated but you did discuss one of them in the London fellowship [meetings](#) on April 24th, 2022. In that reading, you got away with so much because you screened the facts away from your hearers. I must say that I don't like the way that you subtly

switch from Christ and his disciples to James Taylor Junior and his assemblies and then move on to you and your assemblies. If, as you may be inferring, Christ is the first of the great men, that's very serious indeed because members look to you for safe expressions of Christ's divinity.

Why have you so severely separated from me? What have I done wrong? Even in extreme cases, 2 Timothy 2 mentions 'in meekness correcting those that oppose' ([link](#)). Also Jude 4:16 graphically describes the very worst sort of false brethren, pulling no punches, but then suddenly in verse 22 to 23 it says 'have compassion, snatch them from the fire and save them, show mercy'.

I'm suggesting that you might now help me where Garth is refusing, i.e. to provide the finances to enable me to buy a couple of properties which surround the place that I live in at the moment. Their owners would like to sell to me so I immediately need two and a half million pounds to buy these homes. I also have my eye on another development which will cost me four million pounds. With all the profits and wealth in the PBCC at the moment, it would be quite easy for you to facilitate this but it won't ever happen unless you have a change of heart and support me rather than try to destroy me.

This government backed business plan [linked](#) for Weavabel confirms that I would personally be making several million pounds per annum right now if you had not decided to use religious references in my partnership and shareholder agreements against me (drawn up by Garth with the support of Allan ,Lincoln Clarkson and Jed) to take away my property at the time you excommunicated me.

So my request for funding, just to help me establish a safe place in a new area, is perfectly reasonable. I respectfully request that you now transfer the first £2.5 million into my account which would help me to get out of the financial abyss that I have been in since 2017.

There is considerable interest in the properties so I give you 7 days from receiving this letter to make the first payment of £2.5 million. You may need longer to consider providing the £4 million to secure the other property and I will be glad to send you the estate agent's details should you so wish.

It's been eight long years waiting to see my children, my sons in law and daughters in law and grandchildren but Garth continues to turn a blind eye to my requests.
